Ready to find your dream clerkship? OSCAR makes it easy to search and apply for positions online. Take advantage of features such as <u>saving your advanced searches</u> so you can quickly find clerkships based on previously saved criteria without having to enter the same criteria each time. Even if a judge is not currently hiring, you can <u>view their profile and hiring practices</u> to learn about their hiring schedules.

How Do I...Manage My Grade Sheets?

While OSCAR does not accept scanned transcripts, applicants can upload grade sheets in OSCAR via an online grade sheet form. Judges and staff attorney offices are aware that grade sheets in OSCAR are not official transcripts. You may still need to present official copies of your transcripts at any time during the hiring process.
